#### 2. Assessment of implementation of Action activities

## 2.1. Executive summary of the Action

During the reporting period ANNGO staff has improved its technical skill and relations with other parties working in the development of nursery industry.

All the activities are moving according the workplan. The plant bio technology lab is involved to collect leaves samples for virus indexing, bacterial and nematodes. The result of the analysis was shared with FMs and MSN owners.

Meetings held with NHLP, PBTL, RI,DAIL Kabul, a private company (Samsor Ban), GRM staff, ANHDO, ANNGO legal advisor and FMs from Kandahar and Zabul. The purposes of the meetings were better coordination, corporation and membership of companies in ANNGO. During the meeting with NHLP, it promised to support PBTL tissue culture facility for tissue culture of clonal rootstocks (FG677 & Gisela 5). The purpose of the meeting with PBTL was to train FMs for sample collection and improve coordination between NGA and PBTL of MAIL.ANNGO is welling to increase its members. Private companies are suggested to get membership in local NGAs and can produce certified saplings in the areas where ANNGO is actively working.

Inspections of MSNs are under process. ANNGO inspectors along with FMs have inspected Maidan, Ghazni, Logar, Paktia and Bagram nursery grower associations MSNs. The mentioned NGAs have MSNs of stonefruit and pomefruit including cloanl rootstocks. All the Mother trees in the MSNs are in good condition of health and approved for sale of budwood. For minor problems the FMs are instructed improved the MSNs. The grapes MSN of Bagram NGA will be provided polls by other projects working in the area.

The nurseries inspection data/forms which were send by FMs were reviewed and checked regularly during reporting period. All possible TA was provided to FMs.

ANNGO database section has started working on ANNGO website which is expected to be completed in the coming month. The database manager has worked on data entry of the inspected MSNs of north and north east in the ANNGO database.

ANNGO Facebook was updated with the information of NGAs. Similarly ANNGO Technical team has worked on ANNGO catalogue.

Sale of budwood is increasing in and among NGAs. ANNGO plays key role to facilitate the budwood sale programme among NGAs. Most of the NGA have send the budwood estimation and budwood sale of their related NGAs to ANNGO and over 2.5 million budwood is expected to be sold this summer during budding programme. Demand for stonefruit and pomefruit budwood are more among all NGAs. Citrus and low chill peaches budwood requests are more from NGAs in the eastern zone.

Mr.Andrea from EU visited PHDP, ANHDO and ANNGO offices and BBF.ANNGO GM presented ANNGO activities. He was briefed about the certification process in ANNGO main office.

# 3-Workshops, trainings and coordination meetings:

Meetings held with NHLP, PBTL, RI,DAIL Kabul, a private company (Samsor Ban), GRM staff, ANHDO, ANNGO legal advisor and FMs from Kandahar and Zabul. The details of the meetings are as follows:

Meetings with Mr.Ahadi and Mr.Zaki from AFIDS (Afghanistan Institutional Development support) Issues of meeting:

- A. Brief explanation of ANNGO history and activities from GM and ANNGO other staff
- B. GRM programs explanations and activities by 2 guys from GRM Managing collaboration activities of GRM and ANNGO programs and activities.

Participate in Kabul DAIL Agriculture meeting. In this meeting representatives from different Organizations were present.

In the meeting I briefly explain of ANNGO activities (ANNGO as privet sector, Certification Scheme of ANNGO, NGAs, MSNs, Stool beds, Certified Saplings Productions etc) was given. after the explanations the organizations which work on Horticulture Sector were very happy and they wanted have certified saplings from ANNGO / NGAs for their programs.

Two meetings held with ANHDO during the reporting month. In first meeting participate 2 persons from ANHDO and 2 persons from ANNGO participated. The main issues of this meeting were:

- 1. ANHDO and ANNGO join activities
- 2. ANNGO will take membership of ANHDO
- 3. Establishment of ANHDO magazine

In second meeting 3 persons from ANHDO and 2 persons form ANNGO, the main issues were:

- 1. Establishment of editorial committee for Magazine
- 2. Selecting a name for Magazine
- 3. Establishing a procedure for Magazine

Meeting and discussion with Enrica, Prof.Fariwar, Noor, Athar and Hedayatullah Director of Samsur Ban Company regarding revision of ANNGO By-law and membership criteria of nursery growers to NGAs of ANNGO.

In this meeting Prof.Fariwar, Enrica and all ANNGO staff explained to Hedayatullah about revision of comprehensive of ANNGO By-law. It means the ANNGO By-law is opened the door of ANNGO for all nursery growers (single nursery growers, big nursery growers and companies which are producing sapling).

Meeting with Kandahar and Zabul Field Managers regarding:

- 1. ANNGO certification Documents (filling Appendixes)
- 2. Inspections of Certified Nurseries of NGAs
- 3. Bud wood request and estimation of buds in MSNs

Improvements of MSNs ( commercial varieties of fruit species will be as mother trees in the MSNs

ANNGO and ANHDO have regular coordination meetings in these 3 last meetings ANHDO decided to publish magazine by the name "Horticulture Development Magazine" 2 persons from ANNGO are member editorial committee of this magazine.

4. The Project will organise workshops, field days and other similar events under the name of ANNGO and will seek maximum press and media coverage. Following the precedent of similar activities under PHDP, the Project will clearly show the EC funding of the project activities.

The Project will prepare illustrated leaflets in English, Dari and Pashto languages for distribution at shows, and variety catalogues and similar marketing materials in the three languages. These leaflets will include the EU flag to denote the EC funding.
